# Terms and Conditions for HKT POS Promotional Offer HKT POS 推廣優惠條款及細則

#### Introduction 簡介

- 1. These Terms and Conditions govern the promotional offer ("Offer") for the HKT POS mobile application ("HKT POS") provided by Hong Kong Telecommunications (HKT) Limited ("HKT"). 本條款及細則適用於 Hong Kong Telecommunications (HKT) Limited(「HKT」)提供的 HKT POS 流動應用程式(「HKT POS」)的推廣優惠(「優惠」)。
